MISCELLANEOUS: It just became into my awareness just a little while ago that I can confirm this as we suspected you might be called a couple weeks ago we brought this to send it an announcement that as many you know it was just bested chairs and coordinators as well that we have a lot of would appear to be fake students who enrolled in our courses and sometimes dozens in certain classes and what they had in common was they were using outlook.com email addresses and they were also they had no phone numbers and they weren't participating to haven't logged into the course container yet and it turns out that was a fight it was related to Financial Aid fraud it was very sophisticated in our District wasn't the only one that was targeted there were schools throughout the State. I am not sure if it went beyond California as well so right now I don't have a lot of details other than to confirm as we suspected that it related to financial aid fraud and so we're hopefully we'll have some more information in the coming days. That was brought to the attention of Admission and Records folks by faculty member who noticed it so thank to those faculty members and you think it really just sort of underscores the importance of making sure that you're managing your roster and making sure that students who are on your roster are actively participating in your classes if they're not then please drop them, so it is important to manage your rosters.

Additionally we added the distance ED coordinator so there is a you know a really good connection between the Otc committee and DE coordinator because you know as you know the proposal get reviewed there and then get passed on to the curriculum committee so we felt it wise to also include them as an advisory member as our two committees those two pieces of curriculum work together.
