# PLANNING FOR NEXT CYCLE: 2022/2028



## ■ First Step

- District Strategic Planning Timeline
- Spring 2021 Virtual Planning Forum Series
- PIEC Establishes a Strategic Planning Steering Committee
- Begin External Scan (High School graduation rates, labor market analysis, etc.)



## ■ Second Step

- Collect and Collate Feedback on Mission, Vision, Values
- Send Draft Mission, Vision, Values through Participatory Governance Committees
- Collect Internal Data (e.g., SWOT Analysis)



## ■ Third Step

- Collate Information Gathered from Internal Scans
- Formulate Strategic Directions
- Share Strategic Directions with College Constituents and Community



## ■ Fourth Step

- Collate and Refine Feedback on Strategic Directions
- Draft Outcomes Based Action Plan
- Present to Governing Board for Approval



## ROLE OF PLANNING & INSTITUTIONAL EFFECTIVENESS COMMITTEE (PIEC)

### Purpose

- The goal of the Planning and Institutional Effectiveness Committee is to ensure a culture of continuous quality improvement and data-informed decision-making. Best practices for institutional effectiveness include improving equity and student learning and achievement by analyzing data and using results to inform practice. ***It uses environmental scan data as well as institutional outcomes to drive institutional responses.*** The committee reviews program assessment results against the college's mission, values, and strategic goals. ***The committee is also responsible for assuring the continuous integration of planning across the campus, regularly evaluating the college's progress to ensure institutional effectiveness.***





## ROLE OF PIEC (CONT.)

### Responsibilities

- Initiate and review the process for the periodic review of the ***mission, vision, and values***.
- Support program review processes and facilitate data-informed conversations about department and institutional performance ***to drive long-term college planning***.
- ***Analyze data for and support the development of college plans and planning activities.***
- ***Regularly review the progress of the 10-year educational master plan and six-year strategic plan*** to ensure that current efforts are in alignment with these plans, and regularly evaluate progress on achieving goals laid out in these plans.
