PRESENTATIONS/INFORMATION FROM FACULTY GUESTS:

- Christi Vicino updated the committee on the modifications made to the Occupational Therapy Assistant (OTA) courses listed above. The updates are related to a self-study completed for accreditation, which prompted updates to objectives, SLOs, and textbooks. The deleted OTA course has not been offered in years, so the department is removing it.
- Angela Feres shared an update about the modifications to the History (HIST) courses listed above. Updates to textbooks and to remove an English recommended prep that is no longer offered. Assessment processes were also updated. Conversations about how the department is ensuring all courses are reflecting DEI at Grossmont. Other changes to cross-listed courses.
- Paul Vincent updated the committee on the modifications made to the Spanish (SPAN) courses and degrees. General updates to textbooks and key areas like course content, etc. Updates to the degrees are related to the cross-listed courses with the updated Ethnic Studies subject change.
- Bonnie Yoshida-Levine shared about the updates to the Anthropology (ANTH) ADT to reflect subject updates in Ethnic Studies.

Action Item: Instructional Operations will make sure that the courses listed as ETHN 132 and ETHN 133 are updated in degree list to ETHN 137 and ETHN 138 related to a recent course number change in Ethnic Studies.

- Brian Keliher updated the committee about the Business Administration (BUS) new ADT degree that replaces an old degree. Main distinction is the removal of a CSIS course so the ADT could remain at 60 credits. Brian will continue to work with Counseling to make sure students know about the CSIS optional courses related to this degree.
- Diana Vance and Mark Goodman shared about the updates to the SCI course listed above in the removed items that is part of the Chemistry department. The course description was revised to be more general. Other details were removed in other areas and the textbooks were updated.

Action Item: The committee requested that further updates be made to the SCI 110 COR to list examples in sections 9 and 10. Diana and Mark will revise and resubmit for next week's Consent Calendar.

- Jeanette Calo, Breanne Ahearn, and Evan Wirig shared the Media Communication (MCOM) updates with the committee. Some courses got updated titles to be clearer. The department also discussed the DEI components. Overall review and clean up and they are looking forward to seeing how students respond to these updates.
- June Yang and Elisabeth Burke updated the committee on the updates to Religious Studies (RELG) courses and the Philosophy (PHIL) Associates degree. RELG 150 and 170 got new titles to expand and broaden the scopes for each. In addition, the textbooks were updated and include zero-textbook cost (ZTC) options. In this department, a contract grading model is being implemented.
- Sonia Ghattas-Soliman shared an update about modifications to the Arabic (ARBC) course and the French (FREN) Associates degree. Sonia expressed a concern about the use of "Representative Texts" in the COR. Dee provided an update that this language comes from Title 5 and needs to be included on all COR updates.
- Shahrokh Shahrokhi updated the committee about the updates to the Economics (ECON) courses listed above. Prerequisites were modified to match what is aligned at Cuyamaca and the textbooks were updated. He also responded to the committee's questions on the CPR. Both courses are aligned at Cuyamaca.
- Bonnie Ripley shared an update about the Biology (BIO) courses listed above. Note: BIO 140 was pulled from the Consent Calendar at the beginning of this meeting. In general, these courses were due for updates across the board. Some of the courses also have updated Recommended Prep to updated classes in English and Math that are being deleted. The update to the contact hours in BIO 230 is to align this course with others in the department. The department is beginning to have DEI conversations and use supplemental resources for diverse voices.
- Tate Hurvitz and Cindi Harris updated the committee about the modifications and deletions in English (ENGL). The English courses are in three main areas: Composition, Literature, and Creative Writing. The deletions are courses that are no longer offered and many were basic skills courses. The department's main emphasis for updates was in the creative writing area with updates to the titles for some courses. The modifications to the ADT and local degree were a ripple effect from the related course changes.
- Clifton Quinn shared about the modifications for the Computer Programming Associates degree. Modification is to add an optional sequence for students to choose two of the three options: Python Programming (new option), C++ Programming, or Java Programming.
- Sebastien Cormier updated the committee about the modifications to the Physics ADT and Associates degree to remove classes that are being phased out and adding three new courses that are aligned with Cuyamaca. The degree update adds one (1) unit to the Physics degree. This update prompted additional updates in degrees in other areas Chemistry, Math, Geology, Oceanography, and Computer Science. Faculty guests from these departments were on-hand to answer any questions.
- Marion de Koning shared about the updates to the Studio Arts ADT. The department is adding one course as an elective so students have more options. The articulation for the jewelry making course came through so this update can go forward.
- Dee Aceves updated the committee about the General Studies (GE), University Studies (US), and CSU GE Breadth Certificate of Achievement (COA). She worked with Cuyamaca to ensure both colleges have similar updates. Overall the updates provide improved access for students and removes barriers so "Major Modification" forms will not be needed. The COA adds "Area F" (Ethnic Studies for CSU) to the certificate.
- Distance Education (DE) courses were also reviewed with no questions from the committee.

CPR CURRICULUM REVIEW – New Items & Action:

- Nursing Associates Degree Committee reviewed CPR and degree modification in advance of meeting.
 Nursing faculty (Lisa Maloy) presented about the updates. ESL 122 was added as an option for meeting the English requirements. This change will not impact the BRN credit minimums and the few students who may select this would be outliers. The committee had no further questions and agreed to vote on this today.

- History ADT Committee reviewed CPR and degree modification in advance of meeting. Angela Feres
 presented about the updates that had a goal of streamlining the degree and removing redundancy. This ADT
 will now be more aligned to the Guided Pathways model and to a similar degree offered at Cuyamaca.
 ACTION ITEM: Barrow/Hern to approve the History ADT modification: 15 Yes, 0 No, 0 Abstentions. To be
 added to June 2021 Board Packet.

- There was no Tech Review meeting on May 17, 2021, so no informational items to share.
- Work Experience Total Contact Hours Revised proposal:
 - Pending legal action at the state level may change the total contact hours for work experience courses across the board. Until an outcome is announced, no changes will be made at the local/college level on the CORs or in the catalog.
 - Revised proposal is suggested wording for a course level note in Colleague that will appear in the schedule (online and printed versions) beginning in fall 2021.
 - o Committee will review and discuss the revised proposal at the May 25th meeting and may take action or make a recommendation.
