Hello Senators and Guests-


Welcome back for Fall 2024. Now take a big gulp of coffee, pop some no-doz cuz here we go with graphs, tables, and data!

Here is a follow-up on our previous 'Educational Administrator' headcount dilemma.

A bit of review or a 1st time look for our new senators. The following graph was part of a statewide report sent out to us in the Spring from Josh Franklin at Cuyamaca College. Several faculty had questions about where the GCCCD landed and rightfully so:

Educational Administrator Type by TCR, highlight Similar CCDs by # Campuses and FTES

The scatterplot below replicates the prior scatterplot, and now includes red diamonds for 4 other CCDs that have two-campuses and similar number of FTES in 2022-2023.



Note: You don't want to be significantly above or below the regression line in blue. This blue line suggests where you should be relative to the other districts in the state. On this graph, we are at 99, which is more than twice as high as we should be. The blue line suggests we should be roughly at 40 given our fiscal TCR -Total Computational Revenue. We were fairly close to the blue line on other graphs that included faculty headcounts, classified headcounts etc

This is part of a message from me to Dr. Jessica Robinson after she sent out a district-wide e-mail that upped the number on the graph from 99 to 105.

"I don't know how to explain why our district would have more than twice as many as we should relative to other community college districts.

Your thoughts? "

Dr. Robinson:

"I think there may be some confusion regarding job classifications. Educational Administrators include senior leadership (CEOs, VPs, VCs, AVCs) and deans. Classified Managers are a separate category and include directors, coordinators, and supervisors. Any comparisons to statewide or external data need to take this distinction into account as the state totals them separately."

Here is a table to highlight the details of the data she emailed (I have 2 of the 3 full reports below if interested. For some reason, Cuyamaca's doesn't open for copy/paste but I could see in 'Preview'):

In a nutshell:

Summary – Dr. Robinson is suggesting that the 40 in bold is the data point the State should be using and that they incorrectly included the other 65.

Steve: (The following is why us Math types have no friends)

"I just have one nagging detail to resolve. Did the people (person?) who organized this data count all districts the same way or did they only include ' directors, coordinators, and supervisors' (4th Column) for just the GCCCD? We still can't conclude where the GCCCD is with respect to the regression line until we know what data was collected from each district to generate the regression line in the first place.

(Hey, Senators that are still awake -This is the kind of stuff we math peoples love!)

Jessica:

"I am not able to confirm what was counted for the data on the original report as I did not create it. I do know that the data in the report were sourced from the California Community Colleges Chancellor's Office DataMart based on Fall 2022 submitted data. However, the coding for these data was incorrect resulting in the employee information highlighted in that report to be inaccurate. The district is working to correct this for all years moving forward.

I can state that the data below includes our educational administrators and that we do not have 99 (Now 105) Educational Administrators for the entire GCCCD, we have 40."

Does anybody besides me see the irony that our district would suggest that someone else sourced data incorrectly?

Josh Franklin at Cuyamaca College sent this report out initially. I have emailed him to see what he knows.
